



2023 MSAWWA—MWEA JOINT MEMBERSHIP DRAFT Meeting Minutes Thursday April 27, 2023—7:30 am Copper King Hotel/Copper I & II

Opening: MWEA President—Barb Coffman.

MSAWWA Chair—Keeley Barry called meeting to order.

Old Business — Approval of Spring 2022 Joint Membership Meeting Minutes, a motion was made by Rodney Lance, John Alston seconded, and the minutes were approved.

New Business —

- 1. MWEA Delegate's Report—Barb Coffman provided the Delegate's report from Dave Aune, WEF is working on diversity, inclusion, equity issues (DEI), which a top of priority for the National organization. The house of delegates is being evaluated to ensure it aligns with the strategic initiatives.
